## GreenSky<sup>®</sup> Merchant Referral Program

Home Improvement Merchants

- Program Overview: The GreenSky® Merchant Referral Program (the "Referral Program") is offered by GreenSky, LLC ("GreenSky") and provides the opportunity for eligible Merchants participating in the GreenSky® Program ("Merchants") to refer Merchants not currently participating in the GreenSky® Program to GreenSky to receive awards, as described herein.
- Program Details: GreenSky<sup>®</sup> will award one (1) \$250 prepaid gift card (each, a "Reward") to any Eligible Referrer who refers an Eligible Merchant who becomes a Merchant in compliance with these Referral Program Rules (the "Rules") during the Referral Program Period. The Reward will be issued to the Eligible Referrer within sixty (60) days following the first funded loan by the referred Merchant. To receive a payment, an Eligible Referrer must be in good standing with GreenSky<sup>®</sup>. The Referral Program is valid only in the United States and cannot be combined with any other offers. GreenSky<sup>®</sup> reserves the right to add, modify and/or delete any Rewards and/or requirements to receive any Rewards at any time. GreenSky's<sup>®</sup> decision with respect to all aspects of the Referral Program is final and binding. Limit two (2) Rewards per Eligible Referrer in each calendar year.

- Reward Issuance: The Reward will be issued to the Eligible Referrer in the form of an electronic gift card upon satisfactory completion of the requirements outlined herein. If required by GreenSky<sup>®</sup>, the Merchant must complete and submit any additional documentation within a timeframe set by GreenSky<sup>®</sup>, in order to be eligible and receive any Reward.
